FAR 139.319 FAA Approved 40 HOUR BASIC AIRCRAFT RESCUE AND FIRE FIGHTING - \$450.00

This class covers the entire 40 hour "Basic" approved by the F.A.A. as initial training for airport firefighters. Curriculum includes classroom instruction as well as hands-on practical training utilizing firefighting/rescue equipment and procedures. The class also includes practical "live burns" which not only exceed the FAA's minimum requirements under Part 139, but also provides students with valuable experience with different types of extinguishing agents, application techniques, and utilization of safety equipment.

- May 7th - May 11th September 10th - September 14th

FAR 139.319 FAA Required 16 HOUR REFRESHER TRAINING - \$325.00

This class briefly covers the 11 subjects required by the FAA for recurrent training, including live burns. In addition to FAA requirements, new regulatory, OSHA, terrorism/WMD, and fuel farm requirements will be discussed.

- May 24th - May 25th

FAR 139.319 ANNUAL FAA REQUIRED BURNS - \$225.00

This class includes safety briefing and appropriate burns using an aircraft fire simulator.

Burns start at 8:00 am.

- May 11th May 25th June 8th June 29th September 14th September 28th

NOTE - PARTICIPANTS ARE REQUIRED TO ADVISE THE AIRPORT IF YOU HAVE ANY MEDICAL PROBLEMS OR IF YOU ARE TAKING ANY MEDICATIONS THAT WILL HINDER YOUR PARTICIPATION IN THESE CLASSES. FIRE TRAINING PRACTICALS DO REQUIRE STRENUOUS ACTIVITY AND ALL STUDENTS ARE EXPECTED TO PARTICIPATE TO RECEIVE A CERTIFICATE OF COMPLETION. HEPA REGULATIONS ARE IMPORTANT TO OUR INSTRUCTORS AND MEDICAL ISSUES WILL BE CONFIDENTIAL BETWEEN THE INSTRUCTORS AND STUDENTS.

RELEASE OF LIABILITY AND
ASSUMPTION OF RISK AGREEMENT

In consideration for participation in the Aircraft Rescue and Firefighter Training at the Wyoming Regional Aircraft Training Facility, Casper/Natrona County International Airport, I, (name) the undersigned, acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program is significant, including the potential for injury, permanent paralysis, and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist;
2. I knowingly and freely assume all such risks, both known and unknown, even those arising from the negligence of the Airport or others, and assume full responsibility for my participation and injury, accident, disability, or death which may occur;
3. I agree to comply with both written and oral instructions regarding participation in training including, but not limited to, the use and operation of equipment and vehicles. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately;
4. I have disclosed to Casper/Natrona County International Airport ARFF Training Facility personnel all medical problems, conditions, and/or medications that may hinder my participation in training classes and fire training practicals; and
5. I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, fully indemnify, save, and hold harmless Casper/Natrona County International Airport, the Natrona County Commissioners, the Casper/Natrona County Airport Board or its successor, and the officers, agents, and employees of Natrona County from and against all claims, liabilities, judgments, damages, costs, and all expenses incidental to the investigation and defense thereof which may accrue against, be charged to, or recovered from Lessor, directly or indirectly, by reason of or account of or arising out of injury, disability, death, or loss or damage to participant or to third persons or their property or damage to the property of the Lessor caused by the fault, action, non-action, omission, or negligence of Lessee, its agents, or employees and arising out of participation on the Aircraft/Rescue/Firefighter Training Facility. I will give the Airport prompt and reasonable notice of any claim made or actions instituted which in any way directly or indirectly affects or may affect each the Airport's insured, and I acknowledge that the Airport shall have the right to investigate, compromise, and defend itself to the extent of its own interests. The Airport shall have the right, but not the duty to participate in the defense of any claim or litigation with attorneys of the Airport's selection without relieving me of any obligations hereunder. Any final judgment rendered against the Airport for any cause for which I am liable hereunder shall be conclusive against me as to liability and amount
